As a show participant I agree to the Hogeye Marathon Health & Fitness rules and regulations:

1. No refunds will be made to exhibitors who fail to attend the Health & Fitness Expo. All booth spaces must be paid in full prior to set up. One 10' X 10' booth is \$250.00, double booth is \$350.00. Table Skirts provided, but if not needed please request without.
2. **Expo management reserves the right to reject any exhibit and special consideration given to Non-Profits.**
3. Exhibit booth must be staffed at all times during Expo hours.
4. **Booths shall be set up by 12:00 p.m. on Friday March 27 & not be dismantled until close of Expo at 7:00 p.m.!** An additional optional day is on race day, March 28, 7:30-1:00 pm, at the outdoor square on Emma Ave. (Shiloh Square) Runners will be more likely to stop at your booth this day if you are a retail vendor. You must move & set up your own booth, and provide your on internet.
5. Only one exhibitor (entity or business) per booth please, unless approved by race management!
6. Space assignment is by Hogeye Marathon Expo management. We will do our best to accommodate exhibitor's requests.
7. Exhibitor will allow the Hogeye Marathon to take and use photographs of their exhibit space for Hogeye Marathon & Relays promotional purposes.
8. All exhibitors must conform to local fire department and Jones Center for Families rules and regulations.
9. Booth setup shall not extend beyond assigned space or block view on entry into neighboring space.
10. Subletting of booth either partially or in full is not permissible.
11. Hogeye Marathon & Relays, Inc and/or the Jones Center for Families shall not be liable to Exhibitor's agents, invitees, licensees, visitors or to any other person, for injury to person or damage to property on or about the premises caused by the negligence or misconduct of Exhibitor, its agents, servant or employee, or any other person entering upon the premises under express or implied invitation of Exhibitor.
12. Exhibitor agrees to indemnify and hold harmless the Hogeye Marathon & Relays, Inc and/or the City of Springdale, Arkansas, the Jones Center for Families from any loss, attorney's fees, expenses or claims arising out of any such damage or injury.
13. Any use of the Hogeye Marathon & Relays logo/name is **prohibited**.
14. Exhibitor agrees that all belongings must be removed from Expo after close of show, on Saturday, March 27, 7:00 PM
15. The Hogeye Marathon & Relays, Inc. reserves the right to reject or restrict any vendor.
16. Space may be limited so paid booths will take precedent.

Liability Information
